## Additional resolution

This is proposed by the Business Committee, and will be taken at the start of session three:

***General Assembly appoints the Revd Adrian Bulley and the Revd Michael Hopkins as tellers for the election of the Moderator of General Assembly at this meeting.***

This year we are using an electronic voting system, which will collect, count, and collate the votes, so the tellers only job is to receive this information. As Adrian and Michael have been organising this process with the electronic voting company, it is proposed that they be appointed tellers on this occasion.

## En bloc business

Paper H3 – house for duty – has been withdrawn from *en bloc* because of some technical points which required clarifying. The proposers have agreed a revised form with those who raised technical points, and this is now on the website.

## Paper G2

Paper G2 which was omitted from the Book of Reports. Those who requested a hard copy of the Book of Reports have been sent a copy of this paper by post, and it is available to download from the URC website. However, the version on the website was not up-to-date. With apologies for the extreme delay, the URC Trust 2020 Trustees' Report and Financial Statements referred to in paper G2 are now available under the finance section of the General Assembly papers. In view of their lateness paper G2 will not be considered on Friday. Instead the Moderators hope to be able to slot it into the agenda later in the meeting.

### **Pensions discussion video**

Ian Hardie and John Piper, URC Treasurer and Deputy Treasurer note that the Book of Reports for General Assembly 2021 contains two papers, G3 and G4, about pensions. The subject of pensions is unavoidably complex. However, paper G4 contains some really important resolutions that members of Assembly will have to vote on. It is, therefore, important for members of Assembly to engage with the issues so that they can take good decisions that are not over-reliant on the recommendations from the Finance and Pensions Committees. To help and encourage members of Assembly to do this, Ian Hardie and John Piper (Treasurer and Deputy Treasurer of the URC) have prepared a short 'talking heads' video which is deliberately non-technical and light on figures: <https://bit.ly/GApensions>.

A representative of the National Synod of Scotland, in view of that Synod's different safeguarding context.

This amendment is accepted by the Convener, but will still be subject to a vote of the Assembly.
