### Nominations: supplementary report

#### A. Amendments to published list of nominations

Mission Council is asked to note and approve the following additional amendments to the Nominations list that was agreed in May 2017.

#### 2.2 Nominations committee

i. The Revd Brian Jolly is now the North Western Synod member.

#### 3.1 Mission committee

i. The Revd Branwen Rees is now the National Synod of Wales member. Branwen will serve until the end of General Assembly 2022.

#### 3.1.5 Rural strategy group (URC/Methodist)

i. The Revd Steve Faber is now the Synod Moderator co-chair. Steve will serve until the end of General Assembly 2022.

#### 5.8 Investment committee

 Mrs Jean Hudson was appointed at the May 2015 meeting of Mission Council and should therefore be added to the Nominations List. Jean will serve until 30 June 2019

#### 9.1 Northern College

i. Mission Council has previously appointed the following to be URC Governors and notes their end dates:

The Revd Raymond Singh serving to 30 June 2019 Mrs Sheila Davies serving to 30 June 2021.

- ii. Mr Willie Duncan has been serving as URC Governor since 2017. He should therefore be added to the Nominations List with an end-date of 30 June 2021.
- iii. The Revd Dr Robert Pope, the Revd David Jenkins, Mr Steve Wood and the Revd Brian Jolly are no longer serving as URC Governors and should therefore be removed from the Nominations List.

#### B. Correction to a previous decision

The October 2016 meeting of Mission Council appointed Mrs Margaret Brock to serve on the Ministries – accreditation sub-committee (minute 16/46). However, Margaret had actually been invited to serve on the Ministries – maintenance of ministry sub-committee.

Mission Council is therefore asked to rescind, on behalf of General Assembly, its decision of October 2016 to appoint Mrs Margaret Brock to the Ministries – accreditation sub-committee and to appoint her instead to be a Member of the Ministries – maintenance of ministry sub-committee with immediate effect until 30 June 2021.

To effect this correction, the Nominations committee proposes Resolution two.

#### C. New appointments

2.3 Ministerial incapacity and discipline advisory group (MIND)

The Nominations committee supports the request of the Synod Moderators and MIND that the membership of MIND should include a Synod Moderator. The Nominations committee proposes:

- i. Acting on behalf of General Assembly, Mission Council extends the membership of the ministerial incapacity and discipline advisory group to include a Synod Moderator.
- ii. Acting on behalf of General Assembly, Mission Council appoints the Revd Clare Downing to serve as the Synod Moderator on the ministerial incapacity and discipline advisory group until 30 June 2021.

Acting on behalf of General Assembly, Mission Council makes the following appointments:

- 9.1 Northern College
  - i. The Revd Mark Bates, Mrs Rosie Buxton and Mr Bill Potter to be URC Governors with immediate effect until the end of General Assembly 2022.

The Revd John Proctor to be the URC trustee with immediate effect until the end of General Assembly 2022.

#### E. Review Groups

The November 2017 meeting of Mission Council was advised that three review groups had been formed. The groups have now followed due process, completed their work and reported to the Nominations committee. The Nominations committee supports the recommendations from the groups and asks Mission Council to commend the re-appointment of the three post holders to General Assembly as follows:

Clerk of General Assembly – the Revd Michael Hopkins to serve a final term from the end of General Assembly 2020 until the end of General Assembly 2024.

Moderator of the Eastern Synod – the Revd Paul Whittle to continue to serve from the end of his current term on 31 August 2020 until 31 August 2023.

Moderator of the National Synod of Wales – the Revd Simon Walkling to continue to serve from the end of his current term on 31 August 2019 until 31 August 2024.
